OUR WATER PROTECTION AND CONSERVATION PROGRAMS, WHICH FOCUSED ON KEEPING MOTOR OIL, ANIMAL MANURE AND OTHER POLLUTANTS OUT OF OUR WATERSHEDS, REACHED THE COMMUNITY THROUGH SCHOOL PRESENTATIONS, WORKSHOPS AND EVENTS. ONE TYPE OF EVENT ENCOURAGED RESIDENTS TO RECYCLE THEIR MOTOR OIL BY BRINGING IN USED OIL FILTERS AND RECEIVING A FREE REPLACEMENT IN EXCHANGE. ANOTHER PROGRAM WAS SELLING 2,156 DISCOUNTED RAIN BARRELS TO COUNTY RESIDENTS.
